

Land Use Planning Hub Launches in June

The **Land Use Planning Hub** is an informal network that supports the implementation of Alberta's regional plans.

Launching in June 2018, the Land Use Planning Hub connects practitioners and planners from around the province to share information, stories, and feedback related to land use planning. This website was created and is operated by fRI Research, with support from the Land Use Secretariat.

Their mission is to expand regional capacity to deliver regional geographic information services that support regional initiatives through the collaboration of the Edmonton Metropolitan Region Board and the Edmonton Metropolitan Region municipalities

The **Edmonton Metropolitan Region Board (EMRB)** is a regional growth management board consisting of an elected official from the 13 member municipalities (Beaumont, Devon, Edmonton, Fort Saskatchewan, Leduc, Leduc County, Morinville, Parkland County, Spruce Grove, St. Albert, Stony Plain, Strathcona County, Sturgeon County) from within the Region and was established in 2008 as the Capital Region Board.



Land Use Topics Low Impact Development (LID)



Low Impact Development (LID) is a land development approach that recreates natural landscape features in developed areas to minimize the hard surfaces that impede storm water drainage that leads to flooding. LID also manages the collection of storm water rather than just finding ways to dispose of it as well as managing and minimizing the pollutant loads that can be washed into the watershed.

Bill 10: Property Assessed Clean Energy (PACE) legislation

Bill 10: *An Act to Enable Clean Energy Improvements* was introduced on April 12, 2018, to let municipalities establish a Property Assessed Clean Energy (PACE) program that would make it more affordable for Albertans to upgrade their properties without having to put money down. Under PACE, municipalities would install and pay for upgrades on private property and recover costs through the owners' property taxes.

Government Funding for the Municipal Climate Change Action Centre

In order to expand on the programs, that fund solar panel installations, energy-efficiency audits and retrofits, and climate change resilience workshops, Alberta Environment and Parks has pledged \$54 million to enable the addition of multi-year programs for small-scale community generation, energy-efficiency upgrades for buildings, solar energy for schools and more.
